

# Sno Queen, Sno Princess, Sno Flake

## Rules 2011

1. Contestants must submit signed entry form, information sheet and signed acknowledgement of rules to the Chamber of Commerce office on or before **November 25<sup>th</sup>, 2011**. Contestants should also submit a wallet-size photo (with your name on the back) to the Chamber with a self-addressed, stamped envelope if photo is to be returned. No entries will be accepted after November 25<sup>th</sup>, 2011.
2. Only one parent or guardian may accompany contestants to the interview portion of the contest
3. Contestants must be a student at Winters ISD enrolled in grades 6-8.
4. All contestants must be known for their ability to exhibit courteous and respectful behavior toward others, as well as honesty and integrity. Candidate list will be reviewed by school official to determine compliance of this rule. **The candidate** must provide a report card or a typed statement from each teacher that conduct is in satisfactory condition.

This **MUST** be submitted with application and fee. Failure to provide conduct information will result in removal of contestant.

5. Contestants are required to practice solid academic habits and maintain passing grades in all subjects. Proof of passing grades must be turned in with entry form by November 25<sup>th</sup>, 2011. Winner must maintain passing grades throughout her reign. Periodic verification may be required based on circumstances.
6. Contestants must be permanent resident of Runnels County. Foreign exchange students will not be eligible.
7. Each contestant will be responsible for acquiring her own sponsor. Entry fee from a sponsor who is a member of the Chamber is \$25. Non-member sponsor fee is \$30. A parent/guardian/or other family member may sponsor a candidate for \$30. If a contestant cannot find a sponsor, the Chamber of Commerce should be contacted for assistance.

8. Each contestant, along with their sponsor (if sponsor agrees), is responsible in providing her own float or transportation for the parade. If sponsor does not agree to help, then contestant will be responsible for her own transportation. However, the sponsor's name must appear on both sides of float or vehicle no matter who provides it. No more than two contestants may share a float or vehicle and both sponsors must be represented. Please be sure to spell your sponsor's name correctly on your float.

9. Meeting will be held on Tuesday, Nov. 29<sup>Th</sup>, at 5:30 PM at the backroom at DLC Realty for all Sno Royalty contestants. This meeting is mandatory.

10. Interviews will be conducted on December 3, 2011 beginning at 9:00 AM at the Rock Hotel. Candidates should wear Sunday dress – no jeans or tennis shoes.

11. There will be separate judges judging in each age category. Judges' decisions will be final.

12. All contestants will be expected to contact the Chamber office 754-5210 by 1:30 to find out your staging area (where you will be lining up) for the parade.

13. Line-up is at 2:00 p.m. The parade will start at 3:00 p.m. at Compass Bank parking lot. The main parade route for viewing will be along Main Street. Crowning will be at the Rock Hotel at the conclusion of the parade.

14. Winner will be expected to attend all Chamber events whenever possible during the year. Miss Sno-Princess will be notified of each event in a timely manner whenever feasible and accompany and assist Miss Sno Queen and Miss Sno Flake. These events include but are not limited to: Chamber Banquet, Dove Fest, Mayfest and ribbon cuttings.

15. Sno-Royalty is required to be accompanied by a parent, guardian or Chamber official at all out of town function, such as parades and banquets.

16. Conduct unbecoming any Sno-Royalty candidate, including the winner, will be grounds for disqualification from contest and/or removal and loss of title. This includes but is not limited to abiding by eligibility requirements and/or any infractions of the contest rules as defined above, or the laws of the State of Texas. All rulings shall be administered by the Winters Area Chamber of Commerce Directors and shall be final.
